1. I assume the risks of being bitten, scratched, injured or frightened by cats, kittens, dogs and puppies, and any complications that may occur as a result of adopting an animal from SSARF. I will not hold SSARF liable for any injuries, damages, losses, judgments, costs or expenses whatsoever, which I might suffer or sustain in connection with owning an animal adopted from SSARF. ____
2. I have accurately and truthfully completed this Adoption Contract. ____
3. Any modification to this Contract must be in writing and signed by both parties. This Contract is binding upon SSARF, me, and SSARF's and my respective heirs, successors, assigns, executors and personal representatives. ____

Adopter promises to LOVE, to RESPECT and to TRAIN the animal in basic OBEDIENCE.

Adopter promises to CARE FOR the animal in SICKNESS and in HEALTH. Adopter promises that the animal shall live in the house as a MEMBER OF THE FAMILY.

Adopter promises to CHERISH and PROTECT the animal until death do they part.
